### Your Subject Access Rights

Subject to certain exceptions, you have a right to have access to and / or correct any personal information that **the Trumpington Federation** holds about you (your 'personal data').

The purpose of this form is to ensure that all necessary information to complete your Subject Access Request is provided to the **Trumpington Federation**. You will not usually need to pay a fee to access your personal data. However, if your request is unfounded or excessive, we may charge a reasonable fee for complying with your request, or we may refuse to comply.

The term "data subject" refers to the person about whom the information is being requested.
